ENGAGEMENT OF CONSULTANT

National Institute of Immunology is an autonomous research institute of the Department of Biotechnology has the mandate of carrying out high quality basic and applied Research. The Institute invites applications for engagement as Instrumental Workshop (1 post) purely on contract basis.

Name of the Post: Consultant (Level-I): 1 Post (For Instrumental Workshop)

Essential Criteria: I) Masters or Bachelor's Degree From a Recognized University. II) Should also possess 10 years of relevant experience with having good knowledge of software/hardware handling and internet connection related work in the Government/Autonomous Bodies/PSU etc.

Desirable Criteria: (1) The person should have knowledge to configure network switches. (2) To configure Access Points for wireless networks in various places. (3) To fix LAN & WiFi network problems Help in smooth functioning of online/offline important meetings.

Duties & Responsibility: 1) To implement major initiatives envisaged for data generating research projects which requires installation of data storage. 2) Coordination of AMC for web server & website maintenance AMC for UPS's. 3) Maintenance of NII website by updating information and creating necessary links. 4) To coordinate with NICSI for getting the cloud space. 5) He/she should be responsible for ISP related work. 6) Any other work assigned by the HoD/In-Charge. 4. Any other work assigned by the superior authority.

Upper Age Limit: 55 Years

Period of Contract: Initially for a period of one year, extendable by one more year subject to review of the performance.

Monthly Remuneration: Rs. 50,000/- per month consolidated. No increment and DA shall be allowed during the term of contract.

Leave: Paid leave of absence may be allowed at the rate of 1.5 days for each completed month of Service. Accumulation of leaves beyond a calendar year shall not be allowed. Attendance will be marked as per Institution norms.

3. The appointment of consultant is of a temporary nature and can be terminated by giving not less than one months' notice on either side at any time without assigning any reason.
4. The consultant shall be paid a fixed consolidated monthly as per the Guidelines of GOI issued/amended from time to time. No other allowance shall be admissible.
5. The consultant shall be completely accountable for any advice/service rendered by them during their engagement in the Institute in view of the norms of ethical business and professionalism.
6. The candidates, if selected are expected to work independently but under the supervisory control of the concerned departmental In-charge.
