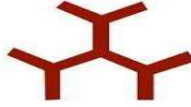

Engagement of the services of Part-Time Medical Consultant

Applications are invited from eligible candidates for engagement as Part-Time Medical Consultant (General Medicine Practitioner) on a contract basis at the National Institute of Immunology (NII), New Delhi.

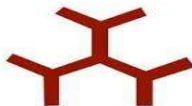
Eligible candidates may submit their applications to the Director, National Institute of Immunology, Aruna Asaf Ali Marg, New Delhi-110067, on or before 11:30 AM on 23.09.2026.

Eligibility, Terms & Conditions:

1. The applicant should possess an MBBS degree from a university recognised in the Allopathic system of medicine under the National Medical Commission Act, 2019, and must hold valid registration with the National Medical Commission or a State Medical Council, which shall remain valid throughout the term of engagement. MD (General Medicine) shall be preferred. Retired government/armed forces/private doctors are encouraged to apply.
2. Candidates should have a minimum of 5 years' experience after MBBS in any hospital. The applicant should not be above 65 years of age as on the closing date of the advertisement.
3. The remuneration of the Institute's Medical Consultant will be a fixed monthly consultation fee (between ₹50,000-60000, depending on experience). The Medical Consultant shall attend the Institute for 2 (Two) hours, from 4.00 p.m. to 6.00 p.m., on all working days and Saturdays, except government holidays.
4. The Contract of engagement will be for an initial period of One year with review of functioning on a half-yearly basis. The term may thereafter be extended on terms mutually agreed between the parties in writing.
5. The Institute reserves the right to review the rate of remuneration from time to time and alter the duty/working hours at its discretion, in consultation with the Medical Consultant, in case it becomes expedient to suit administrative and operative requirements.
6. Interested and eligible candidates may please make an application in the prescribed format (**Annexure-II**). The application should be sent in a sealed cover super scribed as: **"Application for the engagement of Part-Time Medical Consultant on contract basis"**

Selection Procedure:

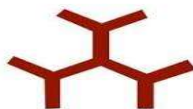
1. The Institute will conduct an interview for the shortlisted candidates. The Institute may adopt shortlisting criteria higher than the minimum eligibility standards in order to limit the number of candidates to be called for interview (eg. qualification, experience, availability, proximity to campus). The decision of the Institute in this regard will be final. Mere fulfilling the eligibility criteria does not entitle a candidate to be called for interview.
2. Apart from those who may be called for an interview, the Institute will not entertain any correspondence with the applicants who are not being called for the interview.
3. Candidates selected for the post will be appointed subject to their acceptance of Terms and Conditions of Contract and Code of Conduct as per Annexure-I.
4. The selected applicant must sign an agreement for contract with the Institute before engagement as Part-Time Medical Consultant (on contract basis) with fixed monthly consultation fee.

Engagement of the services of Part-Time Medical Consultant (on contract basis)
DETAILED TERMS AND CONDITIONS

- 1) The Medical Consultant agrees to offer his/her services, to the serving and retired employees and students and their eligible family members, at the Institute for 2 (two) hour from 4.00 pm to 6.00 pm on all working days and Saturdays, except for Government holidays. The consultations will take place in the NII doctor's clinic in the Gymnasium block. The Medical Consultant undertakes to obtain prior permission from the Institute in case he/she is not able to attend the clinic on any days.
- 2) The Medical Consultant agrees to render telephonic advice in an emergency arising outside the scheduled hour, and to attend the Institute in person in such an emergency, where reasonably practicable.
- 3) The Medical Consultant shall also undertake house visits within the Institute campus, during the consultation hours, whenever necessary, to attend to the urgent medical needs of employees or their family members or students. No separate visit fee or consultation fee shall be charged for such campus house visits. These visits should be recorded and informed to the competent authority.
- 4) The Medical Consultant agrees to render medical/technical advice on the medical certificates submitted by the employees and students of the Institute for their leave requests etc.
- 5) The Medical Consultant hereby represents and warrants that his/her registration(s) with the National Medical Commission or the relevant State Medical Council and any other authorised body are in order and valid during the term of this Contract.
- 6) The Medical Consultant hereby agrees to participate in and attend programs under Corporate Social Responsibility, Medical camps or any other program conducted by Institute from time to time.
- 7) Institute shall pay to the Medical Consultant a consolidated Consultation fee every month on a declaration basis subject to deduction of applicable taxes at Source (TDS). The fee is inclusive of all taxes, and no separate allowance of any kind shall be payable.
- 8) If the Medical Consultant is unable to attend clinic on particular day(s), he/she shall notify the institute in advance, and the Institute shall without prejudice to any other right, be entitled to deduct from his/her consultation fee a proportionate sum for each day of his/her absence from duty.
- 9) Institute shall not make any contributions, including membership fee whatsoever on behalf of the Medical Consultant to any medical associations/clubs, etc.
- 10) It is agreed by the Medical Consultant that the engagement under this Agreement is temporary. The Medical Consultant shall not claim regular employment at any stage or for pay and perks equivalent to Institute employees. No employer-employee relationship shall subsist between the parties, the engagement being on a principal-to-principal basis.
- 11) The Institute may withdraw or cancel the contract by giving one month's notice in writing to the Medical Consultant. Any modification of these terms shall be by mutual agreement recorded in writing. The Medical Consultant may withdraw from the contract by giving written notice of one month.

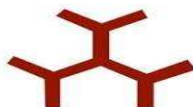

- 12) The Medical Consultant hereby agrees that he/she shall be responsible for his/her own medical negligence and the Institute shall bear no responsibility whatsoever in this regard and Consultant shall indemnify and keep indemnified Institute including all employees and students, against any and all claims raised by third person out of any negligent act of the Consultant.
- 13) The Medical Consultant shall maintain a daily log of patients attended and shall submit a consolidated monthly report to the Administration in the format prescribed by the Institute.
- 14) The Medical Consultant shall not treat employees of the Institute or their family members or students at his/her private clinic on terms giving rise to a claim for reimbursement from the Institute, and shall recuse himself/herself from rendering any opinion on a medical bill arising from his/her own practice.
- 15) The Medical Consultant shall NOT indulge in any act of sexual harassment of any employee as defined by the Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act, 2013. The Consultant shall ensure that a chaperone is present during the physical examination of any female patient.
- 16) The Medical Consultant shall not solicit or accept any gift, hospitality or other benefit from any employee or students of the Institute.
- 17) The Medical Consultant shall not give, solicit or receive, directly or indirectly, any commission, rebate, fee-split or other consideration in respect of the referring, recommending or procuring of any patient, or of any specimen or material for diagnostic purposes.
- 18) The contract is liable to be terminated in case a Medical Consultant is arrested for debt or on a criminal charge or is detained in pursuance of any process of law or commits a breach of the above or the terms and conditions of the contract.
- 19) Disputes pertaining to the terms and conditions of this contract, if any, shall be subject to the jurisdiction of courts in Delhi alone.

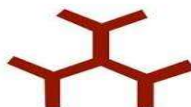
