# Subject: Reimbursement of Children Education Allowance for the FY 2023-24

Consequent upon the decision taken by the Government on the recommendation made in the 7<sup>th</sup> Central Pay Commission on the subject of Children Education Allowance, the following instruction have been issued by the Ministry of Personnel, PG and Pension, Government of India, DoPT O.M. No. A-27012/01/2023-Pers. Policy (Allowance) dated 25.04.2024, DoPT O.M. No. A-27012/01/2023-Pers. Policy (Allowance) dated 14<sup>th</sup> March, 2024, O.M. No. A-27012/01/2022-Estt. (AL) dated 17<sup>th</sup> February, 2023, No. A-27012/02/2017-Estt.(AL) dated 17<sup>th</sup> July, 2018 and OM No. A-27012/02/2017 Estt. (AL) dated 16<sup>th</sup> August, 2017 which are in supersession of Department's OM No. A-27012/1/2014 dated 28<sup>th</sup> April, .2014:-

- a) The amount fixed for reimbursement of Children Education Allowance will be applicable @ ₹. 2812.5/- p.m. w.e.f. 01.01.2024.
- b) The amount fixed for reimbursement of Hostel subsidy will be applicable @ ₹. 8437.5/- p.m. w.e.f. 01.01.2024.
- c) The amount fixed for reimbursement of Children Education Allowance of Divyang Children of employees will be fixed ₹.5625/- p.m w.e.f. 01.01.2024. As per recent instructions of DoPT it clarifies that, in case where Divyang Child is not able to attend school, the reimbursement of CEA for availing education/special education at his/her resident, will be made at double the normal rate of CEA as prescribed under para 2 (D) of OM No. A-27012/02/2017-Estt. (AL) dated 17<sup>th</sup> July, 2018 subject to production of payment receipted by teacher/instructor etc and self certification by the central government servant for availing education for their child at his/her residence.
- d) In case if both the spouses are Government servants, only one of them can avail reimbursement under Children Education Allowance
- e) The above limit would be automatically raised by 25% every time when the Dearness Allowance on the revised pay structure goes up by 50%. The allowance will be double for differently Disabled children.
- f) As per DoPT O.M. No. A-27012/01/2023-Pers. Policy (Allowance) dated 14<sup>th</sup> March, 2024, the Government of India has implemented the New Education Policy 2020 and the following modifications have been carried out in the para 2(p) of O.M. No. A-27012/02/2017-Estt. (AL) dated 17.07.2018:
  - i) "The CEA and Hostel subsidy is admissible in respect of children studying from three classes before class one to 12<sup>th</sup> standard (irrespective of nomenclature of class) and also for the initial two years of a diploma/certificate course from Polytechnic/ITI/Engineering College, if the child pursue the course after passing 10<sup>th</sup> standard and the Government servant has not been granted CEA/Hostel subsidy in respect of the child for studies in 11<sup>th</sup> and 12<sup>th</sup> standards."
  - ii) It has also been decided to grant one time relaxation for reimbursement of CEA/Hostel Subsidy to those Government employees whose children have to repeat one additional class due to implementation of New Education Policy 2020. CEA and Hostel Subsidy in accordance with New Education policy 2020 shall come in to effect from the academic year 2023-24 onwards.

- 2 Further, reimbursement will be done just once a year after completion of the financial year. For reimbursement of CEA, a certificate from the head of institution, where the ward of government employee studies, will be sufficient for the purpose. The certificate should confirm that the child had studied in the school during the previous academic year. For Hostel Subsidy, a similar certificate from the head of the institution will suffice, with the additional requirement that the certificate should mention the amount of expenditure incurred by the government servant towards lodging and boarding in the residential complex. The amount of expenditure mentioned, or the ceiling as mentioned above, whichever is lower, shall be paid to the employee.
- 3 As per clarification furnished vide GOI, DoPT OM 1-1120/1/2014-Estt(AL) dated 28.4.2015, the reimbursement is permissible only if the child is studying in a recognized educational institution. Further reimbursement is allowed to only two eldest surviving children of the Government servant except when the 2<sup>nd</sup> child birth result in multiple births or the 3<sup>rd</sup> child is borne due to failure of sterilization operation.
- 4 Form of reimbursement of Children Education Allowance to be filled-in by the NII staff members is also enclosed. All eligible staff members are requested to submit the same by 7<sup>th</sup> June, 2024 positively in the Administration Department. The applications received after due date will not be entertained.

Note: The reimbursement of Children Education Allowance from 01.03.2023 to 31.12.2023 will be calculated with pre-revised rate @ ₹. 2250/- p.m, Hostel subsidy @ ₹. 6750/- p.m. and for Divyang Children @ ₹. 4500/- p.m.
